NOTICE OF DISCLOSURE OF PECUNIARY AND OTHER INTERESTS

I, CHARLES H.S. TOWN a Member of the Hucclecote Parish Council ("the Parish Council"), set out below under the appropriate headings the interests which I am required to declare under the Localism Act 2011 and the Parish Council's Code of Conduct and I have put 'none' where either I have no such interests under any heading or I am unaware of such an interest.

DISCLOSABLE PECUNIARY INTERESTS

Members are required to register not only their own interests but also those of their spouse or civil partner, or a person with whom the Member is living as if they were a married couple or civil partners, and the Member is aware that that other person has the interest.

I understand that under Section 29 of the Localism Act 2011 there is a legal requirement for the Register of Members' Interests to be published on the internet.


