3. CONTRACTS

Any contract which is made between you or the persons referred to above (or a body in
which you or they have a beneficial interest) and the Parish Council a) under which goods or
services are to be provided or works are to be executed; and b) which has not been fully
discharged.

4. LAND (*See Note)

Any beneficial interest in land which is within the area of the Parish Council (this includes your home or any land or buildings from which you, or the persons referred to above, receive rent).

5. LICENCES (*See Note)

Any licence (alone or jointly with others) to occupy land in the area of the Parish Council for a month or longer.

- (b) either:
 - i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
 - ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you, or the persons referred to above, has a beneficial interest exceeds one hundredth of the total issued share capital of that class.




